At Centene, we believe environmental stewardship is sound business practice. Our mission of providing our members with access to high-quality and cost-effective healthcare extends to our commitment to manage our business operations in an environmentally conscious manner. Centene regularly pursues environmental initiatives in both our operations and on behalf of our members to promote a healthy environment for all.

# **Environmental Governance**

The Governance Committee of Centene's Board of Directors provides strategic oversight into how the company addresses issues of environmental and social importance. This committee meets at least quarterly and through its oversight, makes recommendations to the Board regarding environmental and social responsibility, drivers of health and healthcare reform, and related risks and opportunities for the Company and its subsidiaries. Additionally, the Audit and Compliance Committee of the Board has oversight responsibilities for corporate sustainability financial reporting disclosures and the controls and procedures for the Company's corporate sustainability financial reporting disclosures. Centene's Real Estate & Workplace Resources team is accountable for the day-to-day coordination and implementation of our environmental-related activities, while the Corporate Sustainability team has primary responsibility for reporting and disclosure of environmental metrics.

#### **Environmental Guiding Principles**

We have established Environmental Guiding Principles to serve as the foundation for our environmental and climate commitment.

These principles apply:

- to the operations in our owned or leased facilities
- when developing and providing services for our members
- when working with suppliers, service providers and contractors

#### **Guiding Principle 1 – Conserve**

Streamline the use of energy and resources across our operations.

Reduce our consumption of natural resource inputs to our products and services.

This principle guides our approach for:

- Energy usage
- Water usage
- Waste produced

# Guiding Principle 2 – Clean

Minimize environmental impacts through responsible consumption of resources.

This principle guides our approach for considering or engaging in:

- Energy sourcing and operational efficiency opportunities
- Clean disposal of waste and recycling
- Conservation of natural resources and support for clean water

# **Guiding Principle 3 – Contribute**

Pursue initiatives that generate beneficial climate and environmental impacts beyond the Centene enterprise.

There are many linkages between environmental factors and health outcomes. In addition to the actions we take as a company, we support broader efforts to protect the environment and address climate change impacts to improve the lives of our members in the local markets we serve.

# Guiding Principle 4 – Commit

We commit to operate in compliance with all applicable federal, state and local environmental requirements.
