RURAL HEALTHCARE

Approximately 60 million Americans live in rural areas. On average, rural residents are older and have more complex medical needs. Yet, healthcare access is often limited for these residents. Centene brings care closer to rural populations with mobile clinics, increased access to telehealth services, and by providing transportation to medical appointments.



MATERNAL HEALTH

Maternal health is a critical aspect of public health. On average, Centene manages 290,000 deliveries annually, with over 90% of those births within Medicaid membership. We support our members before, during, and after pregnancy with programs like Start Smart for Your Baby® – an award-winning program that leverages data stratification and AI-enabled analytics to identify members at risk for adverse outcomes, allowing us to intervene earlier. It's been proven to lower the risks of premature births and admissions to neonatal care units.

Lack of access to healthy foods leads to illness, avoidable healthcare costs, and poor health. Three in four U.S. adults have at least one chronic condition, many of which are influenced by diet and other lifestyle factors, and more than 18 million U.S. households experience food insecurity. Food programs have contributed to lowered hospital admissions, improved clinical measures like HbA1c, blood pressure and BMI, and decreased food insecurity.
